SYSTEMS INTEGRATOR PROGRAM CERTIFICATION LEVEL REQUIREMENTS

- You must promote Wonderware products as your preferred solution and represent Wonderware products in a professional manner.
- To remain certified at this advanced level, you must successfully implement at least one Wonderware application annually. Submit a summary of the application project to your local Wonderware Distributor including a customer reference for this application before the end of the current certification period.

<u>Certified Systems Integrator – System Platform:</u>

- Meet the requirements for the Registered Systems Integrator level above, plus:
- Submit proof of two successful installations involving Wonderware System Platform and provide customer contacts for verification
- Maintain at least two Wonderware Certified Developers on staff who are certified on InTouch OR InTouch for System Platform, Wonderware Historian Server and Application Server These can be the same two developers, six different developers or any combination. We also recommend two developers successfully pass the Information server exams but this is not a requirement. Employees become Wonderware Certified Developers by passing our product certification exams which are available online or at distributor sites.
- You must promote Wonderware products as your preferred solution and represent Wonderware products in a professional manner.
- To remain certified at this advanced level, you must successfully implement at least one System Platform application annually. Submit a summary of the application project to your local Wonderware Distributor including a customer reference for this application before the end of the current certification period.

Certified Systems Integrator – Performance:

- Meet the requirements for the Registered Systems Integrator level above, plus:
- Submit proof of two successful installations involving Performance software and provide customer contacts for verification
- Maintain at least two Wonderware Certified Developers on staff who are certified on InTouch, OR InTouch for System Platform, Wonderware Historian Server, Application Server and MES Performance. These can be the same two

developers, eight different developers or any combination. We also recommend two developers successfully pass the Information server exams but this is not a requirement. Employees become Wonderware Certified Developers by passing our product certification exams which are available online or at distributor sites.

- You must promote Wonderware products as your preferred solution and represent Wonderware products in a professional manner.
- To remain certified at this advanced level, you must successfully implement at least one Performance application annually. Submit a summary of the application project to your local Wonderware Distributor including a customer reference for this application before the end of the current certification period.

Employees become Wonderware Certified Developers by passing our product certification exams which are available online or at distributor sites.
- You must promote Wonderware products as your preferred solution and represent Wonderware products in a professional manner.
- To remain certified at this advanced level, you must successfully implement at least one Operations & Performance application annually. Submit a summary of the application project to your local Wonderware Distributor including a customer reference for this application before the end of the current certification period.

<u>Certified Systems Integrator – IntelaTrac ®:</u>

- Meet the requirements for the Registered Systems Integrator level, plus:
- Submit proof of two successful installations involving IntelaTrac and provide customer contacts for verification
- Maintain at least two Wonderware Certified Developers on staff who have successfully passed the IntelaTrac certification exams.
- You must promote Wonderware products as your preferred solution and represent Wonderware products in a professional manner.

Submit a summary of the application project to your local Wonderware Distributor including a customer reference for this application before the end of the current certification period.
